

First Evangelical Church (FEC) Flea Market & Bazaar
Vendor Agreement

1. The First Evangelical Church (FEC) Flea Market & Bazaar will take place in the FEC gymnasium from **9:00am - 3:00pm Saturday, May 2nd, 2020.**
2. **Flea Market & Bazaar Spaces:**
 - Spaces come in various sizes. Please see the Registration Form for dimensions and prices.
 - Spaces **DO NOT INCLUDE A TABLE.** We have a *limited* number of 6 foot tables for rent for an additional \$5.
 - All spaces include 1 chair. An additional chair is available upon request (please note it on the Registration Form under "Special Requests").
 - Electrical outlet access is available in some spaces for an additional \$5.
 - **All merchandise must be contained within the designated selling space.** Do not set anything on space you have not rented or in the aisle.
3. Spaces are payable in advance and only reserved once payment is received. Spaces are available on a first-come first-paid basis.
4. Space must be reserved and paid for by February 28th for Early Bird pricing or April 30, 2020 for regular pricing. Once paid, refunds will only be given if FEC cancels the Flea Market & Bazaar – no exceptions.
5. Payment may be cash or check made payable to FEC.
6. **Payment by Vendor denotes acceptance of all agreement terms and conditions.**
7. **Wifi is not available.**
8. Set up begins at **7:00 AM** and must be completed no later than **8:45 AM.** Tear down begins at **3:01 PM** and must be completed by **4:30 PM.** **Vendors may not pack up and leave prior to closing time.** All items must be removed upon leaving. You must leave your space clean and free of trash.
9. FEC is not responsible for lost or stolen items.
10. Flea Market & Bazaar staff is NOT available for general use by vendors. Our staff is not allowed to lift items.
11. Flea Market & Bazaar staff is all volunteers and do not work in the church office. **For questions or additional information, please contact us at wm@firste.org OR message us through our Facebook page FEC Flea Market & Bazaar.**
12. **FEC retains the right to approve all items offered for sale.** The following will not be allowed:
 - Prepared food of any kind, including beverages
 - Alcoholic beverages for consumption or sale
 - Drugs or drug related items
 - Fireworks, explosives or any kind of incendiary material
 - Weapons or ammunition
 - Offensive or pornographic material

- Counterfeit items or unlicensed merchandise
- Anything contrary to the beliefs of First Evangelical Church

Any vendor who violates any of the above activities or who conduct themselves in a manner which disrupts the market or other vendors, will be removed from the premises. FEC reserves the right to refuse service to anyone.

Indemnity & Hold Harmless Agreement

The vendor/participant assumes responsibility for repair or replacement of any property or equipment damaged during use. The vendor/participant shall indemnify and hold harmless First Evangelical Church and it's assignees, officers, executors from and against any and all claims, demands, actions, suits, proceedings, liabilities, judgments, awards, losses, damages, costs and expenses, including attorney's fees, on account of bodily injury, sickness, disease or death sustained by any person or persons or injury or damages to, loss, or destruction of any property, directly or indirectly arising out of, relating to or in connection with attendance at this event/vending by the undersigned, whether or not such claims, demands, actions, suits or proceedings are just, unjust, groundless, false, or fraudulent; and the vendor/participant shall and does hereby assume and agree to pay for the defense of all such claims, demands, actions, suits, and proceedings.
